ORDER

The petitioner, who was arrested and remanded to judicial custody on 08.08.2024 for the offences punishable under Section 325 of BNS, 2023, and Section 25(1B)(a) of the Arms Act and Sections 9, 39, 51(1) and 51(2) of the Wild Life (Protection) Act, 1972, in Crime No.225 of 2024, on the file of the respondent, seeks bail.

2.The case of the prosecution is that the petitioner along with the other accused, were found in possession of country made gun for hunting wild animals in the reserve forest and also 30 kgs of deer meat. Hence, the case.

3.The learned counsel for the petitioner would submit that the petitioner is innocent and he has been falsely implicated in this case. He would further submit that the petitioner has been in custody for more than 20 days and there is no previous case as against the petitioner. Hence, he prays for grant of bail to the petitioner.

4. The learned Government Advocate (Crl. Side) for the respondent would submit that the petitioner along with the other accused, were found in possession of country made gun for hunting purpose in the reserve forest, without any license and also 30 kgs of deer meat. He would further submit that there six previous cases against the petitioner. However, he vehemently opposed to grant bail to the petitioner.

5. Heard both side learned counsel and perused the materials available on record.

6. Considering the nature of offences and that there is no previous case pending as against the petitioner in same kind of offences and considering that the number of days of incarceration undergone by the petitioner and that the co-accused in this case has been released on bail by this Court, this Court is inclined to grant bail to the petitioner subject to the following conditions:

[a] Accordingly, the Petitioner is ordered to be released on bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction

of the **Judicial Magistrate No.1, Ulundurpet**, and on further conditions that;

[b] the Petitioner shall report before the jurisdictional Judicial Magistrate on every working day at 10.30 a.m., for a period of 30 days and thereafter, as and when required for interrogation.

[c] the Petitioner shall not commit any offences of similar to the offence of which he is accused, or suspected, or of the commission of which he is suspected;

[d] the Petitioner shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any police officer;

[e] the Petitioner shall not abscond either during investigation or trial;

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the Petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]; and

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
