Petitioner / appellatant was convicted for the offences U/s.7 and Section 13(2) r/w 13(1)(d) of the Prevention of Corruption Act, 1988 and sentenced to undergo three (3) years of Rigorous Imprisonment and to pay a fine of Rs.10,000/- in default to undergo six (6) months Simple Imprisonment for offence U/s.7 of the Prevention of Corruption Act, 1988, and to undergo three (3) years of Rigorous Imprisonment and to pay a fine of Rs.10,000/- in default to undergo six (6) months Simple Imprisonment U/s.13(2) r/w 13(1)(d) of Prevention of Corruption Act, 1988, by the learned Special Judge and Chief Judicial Magistrate, Tiruvallur, under judgment in Special Case No.4 of 2013 dated 12.08.2024. Hence, the petitioner seeks suspension of sentence.

2. The learned counsel for petitioner submits that the trial Court was pleased to suspend the sentence on 12.08.2024 and the petitioner / accused is on bail. The learned counsel further submits that there are several infirmities

and inconsistencies found in the prosecution case and there are contradictions in the material particulars between the evidence of the prosecution witnesses.

3.Heard the learned Government Advocate (Crl. Side) and the learned counsel appearing for the petitioner.

4. Considering the facts and circumstances of the case and in view of the fact that there are several infirmities in the prosecution case and there are arguable points involved in the appeal, as contended by the learned counsel for petitioner and that the appeal is not likely to be taken up for final hearing in the near future, this Court is of the considered view that the petitioner herein is entitled to the relief of grant of suspension of sentence.

5. The substantive sentence of imprisonment alone is suspended accordingly, and the petitioner is directed to be enlarged on bail on condition that the petitioner shall execute a bond for a sum of Rs.10,000/-
