The petitioner herein seeks a direction to respondents to issue a separate patta in his name and other sharers as per the partition deed dated 22.04.2022. The petitioner submitted an online application on 05.08.2024 seeking survey of the properties situated in Survey Nos.19/7 and 19/5 at Chinnathukurichi Village, Viruthachalam Taluk, Cuddalore District and issue of exclusive patta in his name and in the names of other sharers. The said application has not been considered till date. Therefore, he is before this Court.

In view of the said position, this Court, without going into the merits of the claim made by the petitioner, is inclined to direct the 1st respondent to consider the online application of the petitioner dated 05.08.2024 in Online Application No.2024/0105/18/403288 and pass final orders on its' own merits within a period eight weeks from the date of receipt of copy of this order after issuing necessary notice to the interested parties.
