ORDER

Pursuant to the order passed by this Court on 15th October, 2024, respondent Nos.1 and 2 are present in Court and identified by Shri Prabakar. Both respondents have filed affidavits dated 21st October, 2024. Shri Prabakar also tendered a compilation of photographs indicating that encroachments have been removed.

2. Though petitioner is present in Court and he is saying that entire encroachment has not been removed, Shri Prabakar, on instructions, states that encroachment to the extent of blocking the pathway has been removed
