2. Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondent.

3. The issue involved in the present writ petitioner was dealt with the earlier writ petition in W.P.No.9394 of 2024 dated 10.04.2024. This Court, after considering the earlier order passed in this regard, issued direction to the concerned Regional Passport Officer. Similar orders can also be issued in the present case, since, the said order will ensure to the benefit of the petitioner also.

In the result, this writ petition is disposed of with a direction to the respondent to receive the application of the petitioner dated 29.07.2024 in form CCPA along with the prescribed fee paid by the petitioner through online for the grant of Auto rickshaw permit and consider the same on its own merits and in accordance with law and pass appropriate orders, within a period of six weeks from the date of receipt
