As the relief sought for in the writ petition is to consider the written representation of the petitioner dated 16.09.2016, this court, without going into the merits of the case, directs the respondents to consider the written representation of the petitioner dated 16.09.2016, based on the Government Order which prohibits issuance of Patta for 'Odai Poramboke' etc., within a period of four months from the date of
