2. The petitioner herein seeks a direction to respondents to survey his property situated in New Survey No.158/4A1D at Padiyanallur Village, Ponneri Taluk, Tiruvallur District by considering his representation dated 12.08.2024.

According to the petitioner, he got right over the above mentioned property under registered settlement deed dated 28.03.2004 and thereafter, the mutation of revenue records had taken place in his name. The petitioner submitted an online application on 30.07.2024 seeking survey of the above mentioned land and the same has not been considered. Hence, he is before this Court.
