2. The petitioner herein seeks a direction to respondent to survey his property situated in New Survey No.158/4B2 at Padiyanallur Village, Ponneri Taluk, Tiruvallur District by considering his representation dated 12.08.2024.

3. According to the petitioner, he got the property under registered settlement deed dated 12.03.2014. Thereafter, the mutation of revenue records had also been taken place. The petitioner submitted an online application on 03.07.2024 seeking survey of the above mentioned land and the same has not been considered. Hence, he is before this Court.

4. The learned Government Advocate, who is taking notice for the respondents 1 and 2, submitted that the online application of the petitioner dated 03.07.2024 will be considered on its' own merits within a time fixed by this Court.
