The petitioner herein seeks a direction to the respondents to survey his property situated in New Survey No.158/4A1B at PadiyanallurV Village, Ponneri Taluk, Tiruvallur District, by considering his representation dated 12.08.2024.

According to the petitioner, the above mentioned property belonged to him under a registered settlement deed dated 28.03.2024 executed by his mother, and patta was also issued in the name of the petitioner based on the settlement deed. Now the petitioner submitted online application dated 30.07.2024 seeking survey of the above mentioned property, the same has not been considered till date. Hence, the petitioner is before this Court.
