ORDER

3. On carefully going through the records, it is seen that the representation/application submitted by the petitioner has been rejected at least on two occasions. The first rejection was on 28.04.2021 and the second rejection was on 11.03.2024.

4. In view of the above, there is no question of once again directing the respondents to consider the claim made by the petitioner. If
