This Writ Petition has been filed to issue a Writ of Mandamus, to direct the respondents to issue membership card to the petitioner by considering the representations of the petitioner dated 21.09.2023 and 19.07.2024 within a stipulated time.

2. Heard Mr.Vijayakumar.N, learned counsel for the petitioner, Mrs.M.Jayanthi, learned Additional Government Pleader for the respondents and perused the materials available on record.

3. The petitioner claims himself as the member of the first respondent from 13.03.2000. The petitioner has stated that he was given with the membership card on 13.03.2000. However, during subsequent renewal, he was asked to produce the earlier membership card issued to him. Despite the fact that he had attached the old card, his renewal has not been done so far and he was not given with the old membership card.
