Writ Petition filed under Article 226 of the Constitution of India seeking issuance of a Writ of Mandamus directing the respondents to pay the petitioner interest for the belated payment of Provident Fund at the rate of 10% p.a.; to pay the petitioner the difference in wages for the period from 01.01.2022 to 31.05.2022 and the arrears of difference in pension for the period from 01.08.2022 to 28.02.2023 based on the petitioner revised salary as on the date of petitioner retirement as per the settlement dated 24.08.2022 with interest at the rate of 12% p.a. to pay the amounts payable under the Family Benefit Fund, Social Security Scheme, Post Retirement Benefit Scheme and the IRT Contribution with interest at the rate of 12% p.a. within a specified time frame as may be fixed by this Court.

ORDER

This writ petition has been filed seeking issuance of a writ of mandamus directing the respondents to pay the petitioner interest for the belated payment of Provident Fund at the rate of 10% p.a.; to pay the petitioner the difference in wages for the period from 01.01.2022 to 31.05.2022 and the arrears of difference in pension for the period from 01.08.2022 to 28.02.2023 based on the petitioner revised salary as on the date of petitioner retirement as per the settlement dated 24.08.2022 with interest at the rate of 12% p.a. to pay the amounts payable under the Family Benefit Fund, Social Security Scheme, Post Retirement Benefit Scheme and the IRT Contribution with interest at the rate of 12% p.a. within a specified time frame as may be fixed by this Court.

2. Heard Mr.G.Vijay Priyan, learned counsel for petitioner, Mr.R.Venkatesaperumal, learned Standing Counsel appearing for first respondent and Mr.C.S.K.Sathish, learned Standing Counsel appearing for second respondent.

3. The case of the petitioner is that he joined the service of the first respondent Corporation as a Driver on 01.07.1990. Ultimately, he

retired from service on 31.05.2022 on attaining the age of
superannuation.

4. The grievance of the petitioner is that even though he retired from service as early as on 31.05.2022, the respondents have settled the terminal benefits only after a period of one year. In view of the same, the petitioner submitted a representation to the respondents to pay interest for the belated payment of terminal benefits. Since the same was not considered, the present writ petition has been filed.

5. Taking into consideration the facts and circumstances of the case and the grievance expressed by the petitioner, there shall be a direction to the respondents to pay the eligible and admissible amount with interest at the rate of 6% p.a. for the belated payment to the petitioner within a period of six (6) weeks from the date of receipt of a copy of this order. It is made clear that if the amount is not paid within the time frame fixed by this Court, it will fetch interest at the rate of 12% p.a. from the date on which the amount became due and payable till the date of actual realisation.
