ORDER

The petitioner, who was arrested and remanded to judicial custody
on 31.07.2024, for the alleged offence punishable under Sections 126(2),
296(b), 118(1), 351(3) and 109 of BNS in Crime No.726 of 2024, on the file

of the respondent police, seeks bail.

2. The case of the prosecution is that due to previous enmity the petitioner attacked the defacto complainant, due to which the defacto complainant was injured. It is also stated that the petitioner threatened the defacto complainant with dire consequences. Hence, the complaint.

3. Learned counsel appearing for the petitioner submitted that the petitioner is an innocent person and he has been falsely implicated in this case. He has not committed any offence as alleged in the FIR. He would further submit that the petitioner was arrested and is in judicial custody from 31.07.2024 and is ready to abide by any conditions that may be imposed by this Court. Hence, he prayed bail for the petitioner.

4. The learned Government Advocate (Crl.Side) appearing for the respondent police submitted that due to previous enmity, the petitioner threatened the defacto complainant with dire consequences and caused injuries to him. He further submitted that the injured has been discharged from the hospital. He further submitted that the petitioner has two previous cases, pending against him. However, he opposed to grant bail to the

petitioner.

5. Heard both sides and perused the materials available on record including the First Information Report.

6. Considering the submissions of the learned counsel on either side, and considering the period of incarceration undergone by the petitioner, and also taking note that the petitioner has two previous cases, in which, he has been released on bail and the injured discharged from the hospital and also considering all others factors, I am inclined to grant bail to the petitioners, subject to certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, each for a like sum to the satisfaction of the District Munsif cum Judicial Magistrate at Gummidipoondi, and on further conditions that:-

[a]the petitioner shall report before the respondent police everyday at 10.30 a.m until further orders.

[b] the petitioner shall not commit any offences of similar nature.

[c] the petitioner shall not abscond either during investigation or trial.

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
