3. The learned counsel for the petitioner would contend that the respondent police have registered a false case against this petitioner for the offences punishable under sections 420 and 114 of IPC. As per the prosecution case, the defacto-complainant is running an educational institution and the petitioner is also running a educational institution and thereby he along with co-accused assured the Defacto-complainant to get loan to the tune of Rs.100 crores and thereby they received sum of Rs.1,61,60,000/- and thereafter they did not arrange any loan to the Defacto-complainant and they did not repay the amount. Therefore, the respondent police registered a case against the petitioner. In fact, the petitioner has not committed any offence as alleged in the FIR. This petitioner is 2nd accused and even according to the FIR, 1st accused only cheated the defacto-complainant and no ingredients to attract the provisions of Sections 420 and 114 of IPC. The petitioner is in judicial custody from 16.07.2024. Hence, he seeks bail to the petitioner.

4. The learned Government Advocate (Criminal Side) would submit that the petitioner and the co-accused have cheated the Defacto-complainant for the sum of Rs.1,61,60,000/- and this petitioner received Rs.16,00,000/- and the co-accused had received Rs.1,12,00,000/- from the Defacto-complainant under the pretext that they would arrange loan for Rs.100,00,00,000/- and thereby they cheated the Defacto-complainant. The amount was not recovered and the investigation is at initial stage and thereby he strongly opposed to grant bail to the petitioner.

5. Heard both sides and perused the materials available on record.

6. Considering the rival submissions on either side and considering the fact that there is a money dispute pending between the parties and also no previous case is pending against the petitioner, no specific overtacts are attributed against the petitioner and also considering the period of incarceration undergone by the petitioner, this Court is inclined to grant bail to the petitioner, subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released on bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, each for a like sum to the satisfaction of the learned **Judicial Magistrate-II, Namakkal** and on further conditions that:

[b] the petitioner shall report before the respondent police daily at 10.00 a.m. until further orders;

[c] the petitioner shall attend in accordance with the conditions of the bond;

[d] the petitioner shall not commit any offence similar to the offence of which he is accused; or suspected, or of the commission of which he is suspected; and

[e] the petitioner shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any police officer or tamper with the evidence;

[f] the petitioner shall not abscond either during investigation or trial;

[g] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[h] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
