ORDER

The petitioner herein seeks a direction to the second respondent to consider the appeal petition dated 11.03.2024 filed by her against the order dated 11.12.2023 passed by the Tahsildhar, Shoolagiri, within a time frame to be stipulated by this Court.

According to the petitioner, she filed an application seeking issuance of joint patta in the names of the present owners of the lands in patta No.1172, Uthanapalli Village, Soolagiri Taluk, Krishnagiri District and the same was rejected by the third respondent by order dated 11.12.2023. Aggrieved by the same, the petitioner filed an appeal before the second respondent on 11.03.2024 and the same is pending without any progress. Therefore, the petitioner is before this Court.

3. Mr.Selvendran, learned Special Government Pleader, who takes notice for the respondents would submit that the appeal of the petitioner would be considered on its own merits and appropriate orders will be passed.
