JUDGMENT

This Writ Appeal is filed against the order of the learned Single Judge
in WP No.17365 of 2024 dated 08.08.2024.

2. By consent of parties, the writ appeal is taken up for final disposal.

3. After elaborate argument, both the counsel for the parties have
agreed for the following terms:

i) Disciplinary proceedings shall be proceeded as against the
appellant and the same shall be concluded within a period of twelve weeks
