ORDER

Alleging that the fifth respondent has encroached on the land comprised in Survey No.92/14A situated in Jaderi Village, Cheyyar Taluk, Tiruvannamalai District, the petitioner sent representations on 9.6.2023 and 14.6.2023 to the respondent authorities. As the said representations did not evoke any response, the present writ petition is filed.

2. Considering the narrow scope of the prayer made in the writ petition, without expressing any opinion on the merits of the

matter, we direct the respondent authorities to consider the representations of the petitioner dated 9.6.2023 and 14.6.2023, on merits and in accordance with law, and pass appropriate orders within twelve weeks from the date of receipt of a copy of this order, of course after affording opportunity to all the interested persons, including the fifth respondent.

The writ petition is disposed of accordingly. There shall be no order as to costs.
