By this miscellaneous petition, the petitioner seeks amendments in specific paragraphs of the writ petition and in the prayer.

2.A counter affidavit has been filed by the 3rd respondent on behalf of the respondents. The principal objection therein is that the miscellaneous petition seeks amendments pursuant to order dated 13.02.2013, which was communicated to the petitioner on 04.03.2013.
