Prayer: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, to call for the records of the third respondent and quash the third respondent/ Teachers Recruitment Board's Provisional Selection List for the direct recruitment for the post of Physical Education Directors Grade I for the year 2020-21 dated 15.09.2022 in so far as the reservation of SC category and over all PSTM category reservation published in the third respondent's official website pursuant to this Notification/ Advertisement in Advertisement No.01/2021 dated 11.02.2021 and Amendment Notification No.O1D/2022 dated 27.08.2022; consequently, direct the respondents to include the petitioner's name in the third respondents/ Provisional Selection List for the post of Physical Education Directors Grade I for the year 2020-21 dated 15.09.2022 as against SC Women category of SC SGT category, by first selecting candidates from SC community (general) for the post of Physical Education Directors Grade I for



the year 2020-21 applying the vertical reservation based on the highest marks and the horizontal reservation for women within the vertical reservation for SC category and by removing PSTM category reservation.
