ORDER

The petitioner herein seeks a direction to the respondent to survey his property situated in S.No.194/2 at Po.Meyyur Village, Padiyandhal Post, Thirukkivilur Taluk, Kallakurichi District, by considering his application dated 16.05.2024.

2. It is the case of the petitioner that the above mentioned property was purchased by him under a sale deed dated 24.06.2020 and he submitted an application dated 16.05.2024 seeking survey of the same, the said application has not been considered. Therefore, the petitioner is before this Court.
