ORDER

(Order of the Court was made by S.M.SUBRAMANIAM,J.)

This writ of habeas corpus has been instituted to direct the third respondent to produce the detainee Ms.Komal Choudhary, aged about 19 years. During the course of investigation, the police found that the detainee and the fourth respondent got married on 05.09.2024 in the presence of the boy's family.

2. The parents of the fourth respondent, who are present before this Court, also made a submission that they have accepted the detainee as the wife of the fourth respondent.

3. The detainee is a major and pursuing education at Coimbatore. She

is capable of understanding what is good for her life. That being the observation made by this Court and the fact remains that the detinue is not in illegal detention, no further adjudication needs to be undertaken. Consequently, the habeas corpus petition stands disposed of.
