ORDER

2. Learned counsel for the respondent/bank submits that the respondent/bank would consider the representations of the petitioner as per the prevalent policy and eligible norms and communicate their decision to the petitioner within two weeks.

In view of the above submissions, without going into the merits of the matter, the writ petition is disposed of with a direction to the respondent to consider the representations of the petitioner dated 9.5.2024 and 2.9.2024, on merits and in accordance with the
