Praying for the issuance of writ of mandamus to direct the 1st respondent to pass final orders in the proceedings in Na.Ka.No.2183/2022/P3 dated 18.08.2023 in the matter of claim of patta by the 3rd respondent for the Lands in question in the name of the petitioner Mosque considering the representation made by the petitioner dated 21.08.2023.

2.It is stated that enquiry was held on 21.08.2023 where all parties have participated. Though over a year has passed, the orders have not been passed by the 1st respondent.
