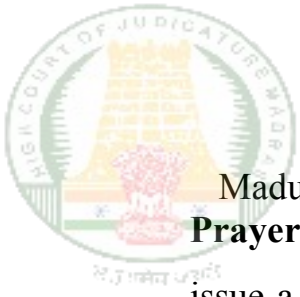

Prayer: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, to call for the records relating to the Government Order vide G.O.(1D)No.134, School Education (Pa.Ka.5)(1) Department dated 18.08.2021 and quash the impugned Clause in paragraph No.4(i)(அ)&(உ) issued by the 1st respondent is concerned and consequently direct the respondents to conduct the transfer/conversion counselling by giving the right of exercising option for relinquishment and to continue as Block Resource Teacher Educators in the same place.
