ORDER

The petitioner herein seeks a direction to the second respondent to cancel the patta issued in the name of the respondents 4 & 5 in respect of the property situated in S.No.765/1C1A1 with an extent of 5.5 cents and the lands in S.Nos.765/1C and 766/1C1.

2. It is the case of the petitioner that the above mentioned property was purchased by the petitioner and four others from the respondents 4 & 5 and others under a registered sale deed dated 14.11.2022. However, the patta was wrongly issued in the name of the respondents 4 & 5 who sold the subject property to the petitioner and others. Therefore, the petitioner submitted a representation before the respondent on 27.11.2023 seeking cancellation of the patta issued in the name of the respondents 4 & 5 and the same has not been considered. Hence, the petitioner is before this Court.

3. Mr.A.Selvendran, learned Special Government Pleader, who takes notice for the respondents 1 to 3 would submit that the representation of the petitioner will be considered, on its own merits, within a time frame fixed by this Court.

4. In view of the same, without going into the merits of the claim made by the petitioner, this Court is inclined to issue a direction to the third respondent to consider the representation of the petitioner dated 27.11.2023 and pass final order, on its own merits, within a period of 8 weeks from the date of receipt of copy of this order, after issuing necessary notice to the petitioner, respondents 4 & 5 and other interested parties.

5. With the above direction, this Writ Petition is disposed of. No costs.
