ORDER

The order of detention passed by the Commissioner of Police, Greater Chennai, in No.757/BCDFGISSSV/2024, dated 05.07.2024, is sought to be quashed in the present Habeas Corpus Petition.

2. The Status Report submitted by the Sponsoring Authority is undated. The above lapses on the part of the authority would be sufficient for the purpose of setting aside the order of detention.
