Prayer: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus, directing the Respondents 1 to 4 to dispose off the representations made by the Petitioner Company on 20.07.2023 and served on the Respondents on 24.07.2023 in which a request has been raised by the Petitioner Company to make the GST payment dues of Rs.187 lakh towards the Works contract of the Petitioner Company being implemented in R.O.C No.3478/2012/MD3 dated 04.09.2015 within a reasonable time frame as fixed by this Court.
