Writ Petition filed under Article 226 of the Constitution of India seeking issuance of a Writ of Declaration to declare that the petitioner herein are entitled to be appointed as teachers (Secondary Grade/B.T.Assistants as the case may be) on the basis of TET marks and TET passed year seniority, having completed certificate verification before 20.07.2018 i.e., the date of passing of G.O. Ms.149, School Education (TRB) Department dated 20.07.2018, without resorting to any competitive examination as stated in G.O.Ms.No.149 dated 20.07.2018, as a measure of equity and fairness as well as on the foundation of the doctrine of promissory estoppel and legitimate expectation.
