ORDER

The petitioner herein seeks a direction to the respondents to survey and issue patta in respect of the land situated in S.No.276/8 by considering his application dated 01.07.2024.

2. It is the case of the petitioner that his grand mother purchased the property on 20.01.1952 and the petitioner and other legal heirs have been in possession and enjoyment of the said property. Therefore, the petitioner submitted an application on 01.07.2024 seeking survey and issuance of patta in respect of the above mentioned land and the same has not been considered. Hence, the petitioner is before this Court.

3. Mr.P.Sathish, learned Additional Government Pleader, who takes notice for the respondents 1 & 2 would submit that the online application of the petitioner will be considered, on its own merits, within a time frame

fixed by this Court.
