ORDER

The petitioner herein seeks a direction to the respondent to survey and measure her property situated in S.Nos.889/2 and 890/2 at Thuppuganapalli Village, Shoolagiri Taluk, Royakottai Sub-Registrar District, Krishnagiri District, by considering her online application in Application No.2024/0123/31/004466 dated 10.08.2024.

2. It is the case of the petitioner that the above mentioned property was purchased by her under a sale deed dated 29.05.2009. She submitted online application dated 10.08.2024 seeking survey of the land and the same has not been considered. Hence, the petitioner is before this Court.

3. Mr.P.Sathish, learned Additional Government Pleader, who takes notice for the respondent would submit that the online application of the petitioner will be considered, on its own merits, within a time frame fixed by
