ORDER

Recording the undertaking given by the learned Government Advocate (Crl.Side) on behalf of the respondents police, the Writ Petition is disposed of with a direction that if any complaint regarding disturbance to the construction work of the temple, the petitioner shall bring it to the notice of the respondent police, the same may be taken note of and an appropriate action will be taken in accordance with law.
