JUDGMENT

We have heard Mr.L.P.Shanmugasundaram, learned counsel for the appellant; and, Mr.P.S.Raman, learned Advocate-General, assisted by Mr.C.Kathiravan, learned Special Government Pleader for respondents 1 and 2.

2. Learned counsel for the appellant/original writ petitioner submits that, though the original writ petitioner was elected on 28.8.2018, the original writ petitioner could take charge only on

3. The said position of the original writ petitioner taking charge of the office on 10.6.2019 is not disputed by learned Advocate-General.

5. The writ appeal, as such, is disposed of. There shall be no order as to costs. Consequently, C.M.P.No.22543 of 2023 is closed.
