This Writ Petition has been filed for a direction directing the fourth respondent to consider the representation dated 12.08.2024 seeking to fix the fair rent at the rate of Rs.12,500/- per month to the petitioner's Shop No.22, Naraseepuram Main Road, Sandhaipettai area, Thondamuthur Panchayat Commercial Complex on par with other shops viz., Shop Nos.3, 9, 15 and 23 instead of Rs.42,598/-.

3. Without expressing any opinion on the merits of the writ petition, the fourth respondent is directed to consider the representation submitted by the petitioner dated 12.08.2024 seeking reduction/fixation
