Since the limited prayer sought for in this writ petition is for disposal of the applications, this Writ Petition is disposed of, by directing respondents 1 and 2 to consider the applications of the petitioner dated 02.05.2022, on its own merits and pass appropriate orders in accordance with law, after giving due opportunity of hearing to the petitioner, fourth respondent herein as well as the adjacent owners of four boundaries of the subject property, rival claimants/interested parties if any. Such exercise shall be done by respondents 1 and 2 within a period of three months from the date of receipt of a copy of this order. There shall be no order as to costs.
