ORDER

The petitioner herein seeks a direction to the respondent to consider his on-line application dated 29.08.2024 seeking sub-division and issue of patta in respect of the property situated in survey No. 211A/7B, Perukkarana Village, Cheyyur Taluk, Chengalpattu District.

2. By consent of both the learned counsel appearing for the petitioner as well as respondent, this writ petition is disposed of at the admission stage itself.

3. It is the case of the petitioner that she purchased the above mentioned property under sale deed dated 19.12.1985 and she has been in possession and enjoyment of the same. Therefore, the petitioner submitted an on-line application on 29.08.2024 seeking sub-division of the property and issuance of patta in her name and the same has not been considered till date. Therefore, the petitioner is before this Court.
