(3) This writ is primarily filed to consider the representation of the petitioner wherein the petitioner has stated that the property which is classified as Gramanatham Poramboke has been under encroachment by several individuals. Conveniently, the petitioner has not impleaded any of the encroachers.

(4) Writ petition of this nature cannot be entertained in the absence of persons who are in possession and who are entitled to be heard.

(5) Hence, this writ petition stands **dismissed**. However, liberty is given to the petitioner to file a fresh writ petition impleading alleged encroachers.
