ORDER

2. The case of the petitioner is that the petitioner made a representation before the respondent Nos.3 and 4 on 22.11.2023 about his discontinuation of studies and seeking to issue Transfer Certificate and his original Certificates, however, the same has not been considered so far. Considering the limited request made by the learned counsel for the petitioner, this Court, without going into the merits of the matter, directs the respondent Nos.3 and 4 to consider the representation of the petitioner, dated 22.11.2023 and pass appropriate orders, on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order.
