Petitioner's case is, respondent No.4 had illegally transferred a sum of Rs.One Lakh from the account of the Athipattu Village Panchayat, Kumaratchi Panchayat Union, Cuddalore District, to his personal account and when the illegality was found, re-transferred the amount to the Panchayat Union account. Counsel states that respondent No.4 should be punished for having dared to commit such an illegality.

2. Mr.Prabhakar states that the present Panchayat President has already lodged a police complaint and police is looking into the matter.
