ORDER

The petitioner herein seeks a direction to the respondents 2 to 4 to consider his on-line application dated 07.08.2024 in challan numbers 20240807031915 and 20240807031600 seeking survey of the land situated in survey nos. 209/1 and 209/2A, Arasangudi Village, Mangalore Block, Veppur Taluk, Cuddalore District.

2. By consent of both the learned counsel appearing for the petitioner as well as respondents, this writ petition is disposed of at the admission stage itself.

3. It is the case of the petitioner that he claims right over the above mentioned property under sale deed dated 20.03.1997 and he has been in possession and enjoyment of the same. The petitioner submitted an on-line application dated 07.08.2024 seeking survey of the land and the same has not

been considered till date. Therefore, the petitioner is before this Court.
