ORDER

The petitioner herein seeks a direction to the first respondent to survey her property situated in S.No.193/2A2 with an extent of 0.36.50 hectares at Kunnathur Village, Uthangarai Taluk, Krishnagiri District, within a time frame fixed by this Court.

2. It is the case of the petitioner that she purchased the above mentioned property under a registered sale deed dated 18.06.2022. Thereafter, she submitted online application on 12.06.2024 in Application No.2024/0123/31/002941 seeking survey of the land and the same has not been considered. Hence, the petitioner before this Court.
