Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying for the issuance of a direction in the nature of Writ of Mandamus, directing the respondents to handover the residential property situated in Grama Natham in Survey No.147/1 Part, to a larger extent of about 1800 sq.ft., in Door No.6/16, 2nd Main Road, New Colony, Velachery, Chennai – 600 003, within limit of Old Ward No.153, New Ward No.179, Greater Chennai Corporation and further directing respondents 1 and 2 to issue “Grama Natham” HSD patta to the petitioners for the house in S.F.No.147/1 Part, to a larger extent of about 1800 sq.ft., in Door No.6/16, 2nd Main Road, New Colony, Velachery, Chennai – 600 003 and pass such further orders.

ORDER
