Writ Petition filed under Article 226 of the Constitution of India seeking issuance of a Writ of Mandamus directing the respondents to pay the petitioner interest at the rate of 18% per annum for the period of delay from 01.03.2020 to 01.06.2021, in paying the amounts paid towards his terminal and pension benefits namely EPF Employee's Contribution, Gratuity, Encashment of Leaves and Commutated Value of Pension, within a time frame as may be fixed by this Court and without affecting his right to claim balance amounts towards those benefits.

ORDER

This writ petition has been filed seeking issuance of a writ of mandamus directing the respondents to pay the petitioner interest at the rate of 18% per annum for the period of delay from 01.03.2020 to 01.06.2021, in paying the amounts towards his terminal and pension benefits, namely, EPF Employee's Contribution, Gratuity, Encashment of Leaves and Commutated Value of Pension, within a time frame fixed by this Court.

2. Heard Mr.V.Ajoy Khose, learned counsel for petitioner, Mr.M.Murali Vinoth, learned Standing Counsel appearing for first respondent and Mr.C.S.K.Sathish, learned Standing Counsel appearing for second respondent.

3. The case of the petitioner is that he was appointed as Junior Assistant in the first respondent transport corporation on 30.04.1988 and

after completion of more than 32 years of service, the petitioner had retired from service on 29.02.2020 as Senior Assistant on attaining the age of superannuation.

4. The grievance of the petitioner is that though the petitioner had retired from service on 29.02.2020, the terminal benefits have been settled only on 02.06.2021 and no interest has been paid for the delay period. In view of the same, the petitioner submitted a representation dated 20.06.2024 to the respondents to pay interest for the delay period. Since the same was not considered, the present writ petition has been filed.

5. Taking into consideration the facts and circumstances of the case and the grievance expressed by the petitioner, there shall be a direction to the respondents to pay the eligible and admissible amount with interest at the rate of 6% p.a. for the belated payment to the petitioner within a period of six (6) weeks from the date of receipt of a copy of this order. It is made clear that if the amount is not paid within the time frame fixed by this Court, it will fetch interest at the rate of 12%
