The petitioners apprehend arrest for the alleged offences under Section 419, 420, 465, 468, 471 of IPC in Crime No.305 of 2024, on the file of the respondent police seeks anticipatory bail.

2. The case of the prosecution is that the land to the extent of 7.00 acres which belongs to the World Missionary Evangelism of India is being managed by the defacto complainant, for which the allegation of the complainant is that when the complainant verifying the revenue records on 31.12.2021, the patta No. 2051 was transferred as Patta No. 4532 with the signature of VAO, Tahsildar without any survey. The accused person namely A1, A2, A5, A6 and others colluded together and attempted to grab the property belongs to the society. The A1 and A2 were tried to sell the property using fraudulent documents. Hence, the complaint.

3. The learned counsel appearing for the petitioners submits that the petitioners are an innocent person and they have not committed any such offence as alleged by the prosecution. The petitioners have been falsely implicated in this case. Even as per FIR no any offence made out against

these petitioners. However, on instructions, the learned counsel further submits that the petitioners are ready and willing to abide by any conditions that may be imposed by this Court and he prays to grant anticipatory bail to the petitioners.

4. The learned Government Advocate (Criminal Side) appearing for the respondent police submitted that the accused person namely A1, A2, A5, A6 and others colluded together and attempted to grab the property belongs to the society by using fraudulent documents and he further submitted that there is no previous case pending against the petitioners. However, he opposed to grant anticipatory bail to the petitioners.

5. Considering the representations made by both sides and considering the nature of allegation leveled against against the petitioners and these petitioners are neither party to the document nor signatory of the document and also considering that there is no previous pending against the petitioner and even as per the prosecution he is the intending purchaser and also considering other factors, this Court is inclined to grant **anticipatory bail** to the petitioners with certain conditions.

6. Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on his/her appearance, within a period of fifteen (15) days from the date of receipt of a copy of this order before the ***District Court, Coimbatore*** on condition that the petitioners shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only), with two sureties, each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned and on further condition that:

[a] the petitioners shall report **before the respondent police daily at 10.30 A.M. for a period of 30 days.**

[b] the petitioners shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts of the Court or to any police officer.

[c] the petitioners shall not leave India without the previous permission of the Court.

[d] the petitioners shall not abscond either during investigation or trial.

[e] the petitioners shall make himself/herself available for interrogation by a police officer as and when required.

[f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]***.

[g] If the petitioners thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
