ORDER

The writ of habeas corpus petition has been instituted to direct the respondents to produce the detainee *viz.*, Priyadharshini, female, aged about 22 years.

2. The learned Additional Public Prosecutor would submit that the detainee had already been traced and she expressed her willingness to join with her parents.

3. The letter given by the detainee to the Police Authorities would reveal that no marriage was solemnized. Under these circumstances, the detainee is willing to continue her studies by staying along with her parents.

4. That being the factum, no further adjudication needs to be undertaken. It is made clear that the petitioner should not cause any disturbance to the detainee or to the family members. In the event of any such interference, the Police Authorities shall take all appropriate actions.
