ORDER

The petitioner herein seeks a direction to 1st respondent to pass orders on the representation submitted by him dated 29.08.2024 making certain allegations against the affairs of the 3rd respondent society.

2. It is the case of the petitioner that 3rd respondent society was registered under the provisions of Tamil Nadu Registration of Society Act and Rules. The petitioner submitted a representation on 29.08.2024 making certain allegations against the administration of the 3rd respondent society. It is the specific grievance of the petitioner that the affairs of the society is not carried on in accordance with by-laws and provisions of Societies Act. However, it not clear whether the petitioner is a member of the society to maintain a complaint against the competent authority to enquire into the affairs of the society. The representation submitted by the petitioner has not been considered by the respondents. Therefore, the petitioner has come before this Court.
