ORDER

This Criminal Original Petition has been filed by the petitioner to direct the third respondent herein to execute the non-bailable warrant dated 10.01.2024, issued by the learned Judicial Magistrate No.1, Virudhachalam against the accused/4th respondent herein in STC No.893 of 2021.

2. The learned Government Advocate (Crl. Side) appearing for the respondent police submitted that on earlier occasion also, non-bailable warrant of arrest was issued against the same accused/4th respondent herein. Thereafter, the accused was secured on execution of non-bailable warrant. Subsequently,

the learned Magistrate released the accused on his own bond and thereafter, the accused failed to appear before the Court for hearing. Hence, once again non-bailable warrant has been issued against the accused/ 4th respondent herein and the respondent police are in search of the accused.

4. Considering the submissions of both sides, the respondent police is directed to execute the non-bailable warrant dated 10.01.2024 issued against the accused/4th respondent herein in STC No.893 of 2021 by the learned Judicial Magistrate No.1, Virudhachalam, within a reasonable time.

5. With the above directions, this Criminal Original Petition is disposed of.
