3. The learned counsel for the Petitioner would submit that the Patta has been transferred in the name of the said Radhakrishnan on the basis of forged and fabricated documents, therefore, the Petitioner has made this representation dated 01.06.2023, which to date has not been disposed of.

Considering the seriousness of the allegations made regarding the grant of Patta in the name of the said Radhakrishnan, the 2nd Respondent is directed to consider the Petitioner's representation dated 01.06.2023 and pass appropriate orders on merits and in accordance with law after affording an opportunity for personal hearing to the Petitioner and the Respondents 4 to 6 as well. In the case of a rejection, a speaking order shall be passed. The aforesaid exercise shall be completed within a period of twelve (12) weeks from the date of receipt of a copy of this Order.
