2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the sister of the petitioner herein dated 01.10.2023 has been revoked by the Government in G.O. [Rt] No.6633, Home, Prohibition & Excise (IX) Department, dated 27.11.2023 and he has also produced a copy of the said order.

3.Recording the submission of the learned Additional Public Prosecutor, this petition is dismissed as the same has become infructuous.
