Prayer: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus, to direct the third respondent to consider the representation of the petitioner dated 07.08.2017 and order to pay outstanding due amount of Rs.15,28,988.00 (Rupees fifteen lakhs twenty eight thousand and nine hundred and eighty eight only) with an interest of 18% per annum from the date of default till realisation of the money for which the works have been already done by the petitioner in respect of ward Nos.13 to 18 and ward Nos. 4, 9 & 12.

4. With the above directions, the Writ Petition stands disposed of. There shall be no orders as to costs.
