The case of the petitioner is that he had lodged a complaint before the 1st respondent on 31.07.2024 against the private respondents for demanding exorbitant interest and also for cheating the petitioner and the same was also forwarded to the 2nd and 3rd respondents. 6. Considering the facts and circumstances of the case, the 3rd respondent police is directed to conduct enquiry on the complaint given by the petitioner dated 31.07.2024 in accordance with law.

7. With the above directions, this Writ Petition is disposed of. There shall be no order as to costs.
